1. Child's birth certificate (enclose attested copy by JP)
2. Father's Pakistani passport and National Identity card (enclose attested copy by JP)
3. Mother's Pakistani passport and National Identity card (enclose attested copy by JP)
4. Two photographs of the child (child's name written on the back)
5. AUD 4.50 (AUD 9.00 for urgent attention) as Money Order or Bank Cheque in favour of Pakistan High Commission (Personal cheques and cash are not accepted)
6. Self addressed envelope (registered post or prepaid courier). Postal charges should not be included in the fee
