1. Applications must accompany:

- a) Original passport (valid at least for six months)
- b) Two passport-size latest photographs (name written on back) attached at the top-right corner of the application form.
- c) Confirmed travel itinerary
- d) Appropriate fee (detailed at (b) below) in bank cheque or money order in the name of Pakistan High Commission. **(Cash and personal cheques are not accepted).**
- e) Self-addressed envelope (registered post or pre-paid courier satchel).

2. If any of the particulars furnished are found to be incorrect or if any information is found to have been withheld the visa is liable to be cancelled at any time. Incomplete and unsigned applications will not be processed.

3. Persons proceeding to Pakistan on specific assignments (business/ official) should enclose letters/documents from their sponsors/employers giving all the details such as the nature of assignment, duration, etc.

4. Applications for visa from nationals of countries, other than Australia and Fiji, will be entertained if they are permanent residents of either of the countries..
