PASSPORT PROCEDURES:

For prompt servicing of your passport please ensure that you observe the following procedures. Failure to observe these procedures will result in delay for which the High Commission will not accept responsibility. In urgent cases higher fees will be charged as indicated. Please advise whether you require urgent attention and if so send the required amount of urgent fees.

FRESH PASSPORT

Fresh passport is issued if (a) validity of the passport has expired or is going to expire within 6 months or (b) pages in the passport have exhausted, or (c) the previous passport has been lost. While applying for a new passport in the case of (a) and (b) above, the following documents are required to be submitted along with the original old passport:

1. **Duly filled in enclosed Form 'A' or Form 'B'** for children less than 12 years of age (signatures and thumb impression (right hand for females and left hand for males) must be affixed at the required boxes on both pages of the form (compulsory).
2. **Old original Passport** (valid or expired).
3. **Original as well as photocopy of National Identity Card** for Overseas Pakistanis(NICOP) or CNIC. NICOP of married women must be in married name and with photograph. Otherwise a restricted passport can be issued which can **only** be renewed on presentation of revised NICOP.
4. **Three copies of recent passport size photographs** with name and signature of applicant on the back.
5. If names of children are to be included in the passport, **two photos of each child and RG-II form** is to be enclosed. Children born in Australia/New Zealand and Fiji are required to be registered with Pakistan High Commission or Consulate General of Pakistan Sydney within 6 months of birth on form 'S'.
6. **Bank Cheque/Money Order** (personal cheques and cash not accepted) for A\$61-00 ordinary (A\$163-00 for urgent attention) in the name of Pakistan High Commission, Canberra. Fee and postal charges can also be paid by credit card. A credit card standing order authority form is also available on our website www.pakistan.org.au with the application forms.
7. **Return Self-addressed Registered post or pre-paid courier satchel**. Charges for return mail in the fee cheque are not acceptable.

In case (c), **loss of passport**, a new passport is issued only after verification by the issuing authority, which may take time. The High Commission, is therefore unable to accept responsibility as to the duration taken for the processing of such passport applications. Application for a new passport in lieu of a lost passport should be, in addition to the above, accompanied by following docs:

- **Original Police Report**
- **Duly filled out Report of Lost Passport (Form enclosed)**
- **Lost Passport Fee:**
First time loss: ordinary: A\$ 122-00 (Urgent: A\$326-00)
Second time loss: ordinary: A\$ 244-00 (Urgent: A\$652-00). No passport is issued for the 3rd lost. Instead a single sheet emergency passport is issued after verification in such cases.

Please note:

1. **Please check-list the requirements (1) to (7) above --once again.**
2. Please send/arrange collection of your documents to/from the High Commission by registered posts or by courier service. All parts of return envelope should be clearly written to ensure prompt delivery.
3. Please **do not** include the mailing charges together with the fee in the cheque. A separate pre-paid self-addressed registered post or pre-paid courier satchel is to be enclosed.
