# INSTRUCTIONS:

1. In case of Pakistani Driving License, it should first be verified from the license issuing authorities in Pakistan by obtaining a NOC / Verification letter from them and thereafter attested from the Ministry of Foreign Affairs in Islamabad or its Camp Offices at Karachi, Lahore, Peshawar & Quetta and thereafter sent to High Commission or Consulate General for attestation in original (NOC).
2. In addition, attested photocopies of the Pakistani driving license, passport, CNIC / NICOP and requisite attestation fee should also be sent.
3. Duly filled in application submitted by the applicant personally or through register / courier mail.
4. Applicants desiring to have letter of authenticity of the license or requesting confirmation of name as appearing in license etc must also fill the statutory declaration signed by Notary Public or J.P. and submit the same to the High Commission or Consulate General in original. This declaration would be enclosed in the letter addressed to the relevant RTA.
5. You have to attach a self addressed Express or Registered Post return envelope if you are sending documents by post.

**Processing Fee:** AU\$ 20.00 (non-refundable)

**Processing Time:** 5 working days (only if the documents are satisfactory and genuine).

## Mode of Payment:

1. In case of High Commission for Pakistan, Canberra, POSTAL MONEY ORDER / CERTIFIED BANK CHEQUE / BANK DRAFT in favor of "**High Commission for Pakistan, Canberra**".
2. In case of Consulate General of Pakistan, Sydney, you can send POSTAL MONEY ORDER / CERTIFIED BANK CHEQUE / BANK DRAFT in favor of "**Consulate General of Pakistan Sydney**".
3. All types of **Credit / Debit Cards** are also accepted for payment only in the **Consulate General Sydney** through **EFTPOS machine** at the Consular Services Counter.
4. **No Cash is accepted in any case.**
